#### 5TH EXECUTIVE COMMITTEE MEETING, SAN FRANCISCO, USA, FEBRUARY 9, 2017



The 5th Executive Committee Meeting was held at the Stanford Center on Longevity, San Francisco, USA on February 9th, 2017. The agenda of the meeting included: 1) Reports from IAGG Regions, Headquarters, and Sub-Organizations, 2) Report on the 21st IAGG World Congress, 3) Re-proposal of the IAGG Structure (WAA & DIRA), 4) Selection of a Tentative Agenda for the next Council Meetings, 5) Selection of Winners of Presidential Awards, 6) Appointment of Directors to GARN & WAA, and 7) Others.

To present the progress of the planning for the 2017 IAGG World Congress, Executive Director Mr. James Appleby and Rachel Puffer from the Gerontological Society of America joined the discussion. The meeting was meaningful as most delegates were highly engaged in discussion.

# IAGG PARTICIPATES AT UNITED NATIONS 55TH SESSION OF THE COMMISSION FOR SOCIAL DEVELOPMENT, 1 - 10 FEBRUARY 2017

IAGG President Prof. Heung Bong CHA and IAGG Secretary-General Prof. Sung Jae CHOI, accompanied by IAGG Representatives to the UN Prof. Martha BIAL and Prof. Hans STÖHRER, represented our organization IAGG at the Fifty-Fifth Session of the Commission for Social Development (CSocD55), which was held 1 to 10 February 2017, at United Nations Headquarters in New York. The priority theme for the 2017-2018 CSocD55 review and policy cycle is "Strategies for eradicating poverty to achieve sustainable development for all".

IAGG has participated in and contributed to the work of all annual Sessions of the Commission for Social Development over many years, as summarized in the Four-Year Report of IAGG Activities at the UN in the IAGG Newsletter of December 2013 (Vol. 20, No. 1), and as noted in the IAGG Newsletters since then.

The Fifty-Fifth Session of the CSocD, held 1-10 February 2017, brought together 40 official State Members of CSocD, 98 Member States of the United Nations represented by observers, 7 intergovernmental organizations with standing invitation to participate as observers, 6 United Nations agencies, funds and programmes, and 3 United Nations Regional Commissions. The CSocD55 organization of work consisted of several high-level panel discussions on the priority theme, on poverty and youth, and on poverty and disability.

A message statement from the new United Nations Secretary-General Mr. António GUTERRES to CSocD55 focused on the prevalent inequality and unequal distribution of progress in the world. A statement from the Director of the United Nations Department of Economic and Social Affairs (DESA) Division for Social Policy and Development (DSPD) Ms. Daniela BAS, focused on disability, youth, and ageing, in regards to the third review cycle of the 2002 Madrid International Plan of Action on Ageing (MIPAA), adopted by the Second World Assembly on Ageing in Madrid in April 2002, and as called for in the agenda of CSocD55 in follow-up to the World Summit for Social Development and the 24th special session of the General Assembly.

The first five-year MIPAA review and appraisal concluded in 2008 with a global review at the Commission for Social Development at its forty-sixth session. The second MIPAA review and appraisal process started in 2011and concluded in a global review in 2013 at the Commission for Social Development at its fifty-first session. The mandated timeline for the third review and appraisal of MIPAA is scheduled to conclude in 2018 at the fifty-sixth session of the Commission for Social Development, following a participatory "bottom-up" process, involving civil society and older persons themselves, national reviews, regional reviews coordinated by the 5 United Nations Regional Commissions, and global review.

Contributions of Member States to CSocD55, following the prescribed priority theme and agenda, focused on youth, the disabled, and on ageing. Older persons are recognized as a vulnerable group, with the need for inter-generational solidarity, and the people-centered approach to development advocated in the 1995 Copenhagen Declaration. Older persons are recognized as a key population in implementation of the 2030 United Nations Development Agenda. Several Member States also emphasized the need to discuss a legally binding international instrument on the rights of older persons, stressing that measuring the protection of older persons, in the reviews of MIPAA and the Social Development Goals (SDGs), will be a key to measuring the implementation of the 2030 Development Agenda.

The IAGG delegation, contributing during discussion of the agenda item on MIPAA, delivered an Oral Statement to the Fifty-Fifth Session of the Commission, read by Prof. STÖHRER on 7 February 2017. In its statement, in regards to the priority theme, IAGG recommended and urged Member States to implement three strategies for eradicating poverty among older persons, which strategies are called for in the Madrid International Plan of Action on Ageing (MIPAA): encouraging employment of older persons; institutionalizing universal pensions; and increasing education and training of geriatric health care

providers.

Concluding its fifty-fifth session on 10 February 2017, the Commission for Social Development approved three draft resolutions for adoption by the Economic and Social Council that addressed issues of African development, youth and the rights of persons with disabilities.

#### **IAGG-GSIA (GLOBAL SOCIAL ISSUES ON AGEING)**

#### **REPORT TO THE IAGG EXECUTIVE, FEBRUARY 2017**

The mission of the GSIA is to consolidate and extend knowledge of population ageing in the context of global economic, environmental and structural changes. We are mindful of the power of contexts of ageing in shaping regional discourses; and that these discourses are important in determining uptake and use of the data we create.

GSIA principles and activities are based on the belief that the IAGG should be the global voice for evidence-based policies and that will foster "the highest quality of life and well-being of all people as they experience ageing at individual and societal levels" (IAGG mission statement). There is much to be done. Inequities are increasing both across and within nations. Marginalization, social exclusion and isolation of older persons remain far too common.

#### **GSIA KEY PRINCIPLES AND ACTIVITIES.**

The purpose of this briefing note is to highlight key GSIA principles and examples of recent activities and to present an agenda for moving forward.

Principle 1. Knowledge about social issues in global contexts requires input from all world regions.

The GSIA does not seek to duplicate the fine scholarship in social gerontology occurring in most world regions. Rather it seeks to foster establishment of collaborative and critical thinking; and knowledge creation and dissemination at the interfaces of regional issues and global trends.

**Principle 2.** Capacity building is needed to enhance knowledge about regional commonalities, to foster collaborative linkages among emerging and established scholars, to enhance skills in creating these linkages, and to model the advantages of such collaboration.

**Principle 3.** Elitism in global scholarship must be challenged. Especially in developing countries, scholars face considerable barriers in their access to the resources needed to create sound scholarship and to gain access to international debates and collaborations. The IAGG must be proactive in ensuring that voices of all of its constituents are valued and heard.

**Representative Activities.** In the first phase of the GSIA activities, three global social issues were identified. They are described below along with a small number of activities that illustrate research, capacity building and dissemination activities around these thematic areas.

- <u>Families</u>. There is much discussion and considerable evidence of flows of family support up and down generations. Yet there is rising concern about the abilities of families to sustain such support in the face of poverty, civil disruption, migration and changing family structures. Objectives in this theme are to identify global trends in discourses and realities of family strengths and obligations, toward creating strategies for strengthening and supporting them.

#### **IAGG MEETS TO DRAFT IAGG QUADRENNIAL REPORT TO UN ECOSOC FOR YEARS 2013-2016**

The IAGG delegation, convened by IAGG President Prof. Heung Bong CHA and IAGG Secretary-General Prof. Sung Jae CHOI, met together to continue an iterative exercise to draft the IAGG Quadrennial Report submitted to United Nations Economic and Social Council (ECOSOC) for the reporting period of years 2013-2016. The last IAGG Quadrennial Report submitted to UN ECOSOC was for the reporting period 2009-2012. IAGG is an NGO in General Consultative Status with ECOSOC from 1978 to 2008 and in Special Consultative Status with ECOSOC since 2009.

Under ECOSOC resolution 1996/31, NGOs in general and special consultative status with the Economic and Social Council must submit to the Committee on NGOs a brief report of their activities every 4 years, known as the Quadrennial Report, which includes information about contributions of the NGO to the work of the United Nations.

The consultative relationship is a reciprocal one. NGOs are granted the privilege of participating in a wide variety of United Nations-sponsored events, meetings and activities. In return, they are expected to contribute to the development aims of the Economic and Social Council (ECOSOC), and the United Nations at large, based on their relevant areas of experience and expertise. Thus, the Quadrennial Report presents an opportunity for NGOs to inform Member States about their activities in support of the United Nations, and at the same time, receive feedback from Member States on their program of work as well as an official acknowledgement of their contribution as partners in development. The quadrennial review exercise therefore serves as a critical tool in monitoring the relationship between the United Nations and the steadily growing number of NGOs in consultative status with the Economic and Social Council.

# FIFTY-FIFTH SESSION OF THE COMMISSION FOR SOCIAL DEVELOPMENT ORAL INTERVENTION BY IAGG FEBRUARY 7, 2017

Good morning,

Honorable Mr. Chair,

Distinguished Delegates,

Thank you for the opportunity to address this Session of the Commission for Social Development.

The International Association of Gerontology and Geriatrics (IAGG), founded in 1950, with its 83 member societies representing over 50,000 professionals across 70 countries worldwide, conducts scientific research and provides education and training to professionals in ageing.

We recommend the following three strategies for eradicating poverty among older persons:

- 1. First, enabling people to remain in the labor market as long as they can as they age. This requires:
- a. Training and education for older adults to upgrade skills in order to be productive in an information and knowledge based economy.
- b. Legal prohibition of age-discrimination in employment, lay-offs or retirement.
- c. Enabling people to remain in the labor market may reduce the financial burden to governments of social assistance programs.
- 2. Second, institutionalizing a universal basic pension to ensure that older persons will escape absolute poverty, whether that pension is contributory or non-contributory.
- a. According to a 2015 report on "World Population Ageing" from the Population Division at United Nations Department of Economic and Social Affairs (UN DESA), in countries where government provides pensions, the poverty rate for older adults is often lower than that of younger people. Where there are no pensions, the poverty rate for older persons is higher.
- b. Many countries offer no retirement benefits at all and others offer pensions for a select few, for example civil servants, and the amount is often meager.
- c. However, pensions frequently add to the total family income, lifting whole families out of poverty.
- d. Pensions provide older persons with some independence, making them less vulnerable to abuse.
- 3. Third, increasing education and training of geriatric health care providers.
- a. Poor health and lack of competent health care is a form of poverty.
- b. Currently there is a severe world-wide shortage of geriatric physicians and allied health professionals trained in the unique health care needs of older persons. This puts older adults at risk of premature disability, which leads to an early departure from the workforce. This in turn puts the involuntary retirees at high risk of poverty.

All three strategies are called for in the Madrid International Plan of Action on Ageing (MIPAA). The Independent Expert, who has been monitoring the implementation of the Madrid Plan, said in her report of July 2016 that while she observed many "best practices" in implementing these items, progress is uneven and much still needs to be done.

Therefore, in conclusion, we urge Member States to implement these three strategies—encouraging employment of older persons, universal pensions and increased training of geriatric health care providers. We believe improving the health and economic well-being of older persons will contribute to sustainable development for all.

#### **DUTCH SOCIETY FOR GERONTOLOGY (PRESIDENT RUUD KEMPEN)**

#### **Issues on older people in Dutch National Elections**

On March 15, 2017, national elections for a renewed parliament and government will be held in The Netherlands. At least two issues related to older people dominate the discussion between the numerous political parties. First, the current government decided a couple of years ago to increase the age of retirement from 65 years in steps of 3 months each to 67 in 2021. From then the age of retirement will be derived from (rising) life expectancy. However, despite the substantial costs of 12 billion Euros, several political parties now stated that they will decrease the age of retirement again to 65 years when they gain sufficient political power. Second, most political parties promise that they will reduce or abolish the insured liability of paying the first 385 Euros to all citizens and/or increase particularly investments in long-term care for older people (i.e. home care and nursing home care). The sum of money for the latter additional investments varies from 1 to 4 billion Euros on a total yearly budget of 23 billion Euros for long-term care.

#### **Activities of the Dutch Society**

On February 9, 2017, the Society organized a successful symposium on diversity in informal caregiving on The Dutch National Geriatric Days that were held in 's-Hertogenbosch, The Netherlands. Papers included gender differences in care burden among partners of older people, different patterns in informal caregiving in different care settings (i.e. at home versus in nursing homes), the impact of care need characteristics on care burden of caregivers, and differences between caregivers in their use of digital communication in their care networks. In addition, members of the Society were involved in the organization of The Dutch National Geriatric Days and participated in several other symposia. Future activities of the Dutch Society.

On May 19, 2017, the Annual Meeting of the Society will be held. Along with this meeting, a symposium on Senior Friendly Communities will be organized that includes a general introduction to this topic after which two examples of Dutch senior friendly communities (the cities of The Hague and Amsterdam, respectively) will be presented and discussed. The symposium is open to society members as well as anyone interested.

On November 3, 2017, The Dutch National Congress of Gerontology will be organized by the Society. This year's theme is "Innovation in Ageing" with the focus on prevention. Next to two key lectures (including the Second Annual Prof. dr. D.L. Knook Lecture by professor Tom Kirkwood from the Institute of Ageing at Newcastle University, UK) 20 to 30 symposia and poster sessions, particularly for younger researchers, are scheduled. Registration will be open soon.

Last year was the Anniversary Congress of the Hungarian Association of Gerontology and Geriatrics (founded 50 years ago) and we organized a postgraduate course of geriatrics.

In the last year the Dementia Screening Program was connected with the Nationwide Mobile Health Care Program and continues this year as well.

In April 2017 will start the new website (<a href="www.idosgyogyaszat.hu">www.idosgyogyaszat.hu</a>) and the newly established Journal of our Society. We have begun to edit the first Hungarian Textbook of Geriatrics.

The neuropsychological profile in individuals with vascular disorders depends on the specific condition investigated. In all conditions cognitive impairment is a risk factor for dementia. A better understanding of which cognitive domains are affected in different disease groups could help improve operationalisation of the neuropsychological criteria for VCI-ND and could also aid with the development of dementia risk prediction models in persons with vascular disease.
